PASTOR'S REPORT

First, let me say thank you for welcoming David and I into your congregation. Both of us have loved getting to know all of you, and we are just so excited to be settled into a congregation. I was called to be your pastor in September, and I feel like we have accomplished so much already together.

I've had the opportunity to visit some folks who live in nursing homes or assisted living centers. We celebrated the lives of Mary Ross and Marilyn Lobert. We organized a meal train, attended neighborhood events, and witnessed to the gospel. We held an Advent Study on the holy disruption Jesus brings into the world. We worked with local officials to host a forum on gun violence and trauma.

Yes, our congregation is small. Yes, we have many questions about the future, the building, the finances, etc. But God is working in and through us. God is doing a new thing. We are starting to feel the Spirit move in the air around us.

Coming from a New Worshiping Community, I have some quirks that I'm sure you're starting to pick up on. One of my deepest desires is to make worship accessible—removing barriers people may have from experiencing the Divine. That might mean singing hymns in multiple languages or finding ways for kids to be more involved. We've started shifting some things around in the worship service to do this. I've added context in the bulletin for our various practices and a clear welcome to worship services that sets the tone for our time together. But that's just one quirk.

Another is a desire to be deeply involved in the community around us. This is part of why I'm excited to be here at FPCE—you've said you also want to do this. In the work of grassroots organizing, there is a strategy called Asset-Based Community Development. Every week, we invite you to bring your gifts during the offering—for some, this is financial. For others, it's skills—cooking, sewing, plumbing. ABCD says, "You already have everything you need, but you've barely scratched the surface. Let's dig deeper together."

My hope for 2023 is that we dig deeper. I want us to take a step back and look at our history, learning about the needs and resources already present in Edgewood and the surrounding area, learning how we can help connect these resources with those who need them. As the church, we are called to serve and create opportunities for care. How might we step up in this new year? How will we seek to ally ourselves with the School for the Deaf or the CC Mellor Library? Will we accompany Wilkinsburg Community Ministry on the ground? Will we listen to those suffering the effects of gun violence in our neighboring areas? How will we respond to the love we've been given in Christ?

I'm excited to get started as we hold elder and deacon trainings as well as a new member class, but that's only the beginning. We must discern the Spirit together. We need you to speak up and share what you're hearing and feeling. *How* is the Spirit moving? What *causes* are laid on your heart? How can we accompany each other as we seek to become the Beloved Community?

CHRISTIAN EDUCATION REPORT

I will instruct you in the way you should go, I will counsel you with my eyes upon you." Psalm 32:8 "For where two or three gather in my name, there I am with them." Matthew 18:20

During 2022, Christian Education remained a vital ministry here at FPCE. Despite our ongoing saga with COVID and the fact that we did not have a Pastor until September, we enjoyed multiple CE programs.

Tuesday Morning Book Group met steadily throughout the year. At our peak, we swelled to 11 members. The book group continues to act as fellowship; support/prayer group; and theological discussion group. During 2022, we read "The Scrolls from the Dead Sea" by Edmund Wilson; special favorite "The Stranger in the Lifeboat" by Mitch Albom; least favorite "Pilgrim's Progress in Today's English" by John Bunyan retold by James H Thomas; thought provoking "The Fifth Gospel" by Ian Caldwell; "A Man called Peter" by Catherine Marshall; and a beautiful advent book, "In the Manger" by Max Lucado. We learned about the scrolls found in Israel and Palestine; Jesus' presence in our lives; our journey toward salvation; the difference between the Orthodox and Catholics; the great schism of 1054; the Fourth Crusade; the Diatessaron; and the Gospel of John. A highlight of our year was in October, Pastor Jason met with the group in response to our post "Fifth Gospel" concerns and led a presentation on the Gospel of John compared with the Synoptic Gospels. We look forward to many more meetings.

CE also offered a weekly Wednesday evening Bible Study via Zoom during several months in 2022. This well thought out study was taught by Tim Hoffman, teacher extraordinaire. The curriculum was the Bible. This year, we read the stories of Joseph and some of the Prophets. Tim highlighted comparisons between the life of Joseph and Jesus. He also discussed what the Bible says about the unborn. We have a small faithful group participate in these lessons and prayer which has greatly improved my Biblical knowledge and understanding.

During December, Pastor Jason led an Advent Study based on the book "Holy Disruption" by Tracy Daub. This study attracted different people, not the CE regulars. We had 14 people get the book, both members and nonmembers. The hybrid study met on four Thursdays in December with individuals attending both in person and via zoom. In the study, we focused on Mark's Gospel discussing a radical Jesus rather than the conventional cozy Christmas message.

Finally, Youth Sunday School continued weekly in 2022. Lorraine Douthett and I take turns leading the class which is often based on the Lectionary and Sermons 4 Kids curriculum. We are thrilled to have 3 very bright and active children (ages 4 - 6, now 5-7) join us for Bible Lessons, coloring, games and crafts. We also enjoyed the participation of visiting grandkids. We were especially proud of our prayer rocks, Advent banners and cards we made for the Deacons to hand out at Christmas.

We invite all members or friends to join us for any of our programs. Please let us know if you have any other interests, talents, or callings for Christian Education; Fellowship; and Spiritual growth.

It is my sincere hope that in our music ministry all feel that they are heard, loved, and treasured. A term that I've used recently that sums up where we've been heading in the past year or so is a "ministry of music hospitality." Through our partnerships with community musical organizations, our regular music ministry has expanded beyond our own choir and worship ensemble to include many more voices.

Let's take a quick look back at 2022:

Winter

Just when we thought we were out of the woods with Covid, the Omicron variant reared its ugly head and out of an abundance of caution, we took a "pause" on our music ministry activities for about a month between January and February. We reverted to just me and Sunny leading the music and encouraging masks again for all in worship.

Spring

- On March 12, the Edgewood Symphony held a concert in the sanctuary featuring the full orchestra for the first time in a performance since 2019.
- Our Sanctuary Choir and Worship Ensemble returned to participating in our worship services for Lent.
- As we journeyed through Holy Week in April, our Sanctuary Choir members presented a Palm Sunday reader's theater "on the street interview" crafted by Lisa Segedy.

<u>Summer</u>

- It's been a good number of years since we put on a "Jazz Vespers" style worship service. On July 10, our congregation was treated to "The Good Word in Music," a worshipful experience that centered on music with several beautiful piano offerings by our gifted pianist, Sunny Sakai, and reflections about those pieces read by Jim Segedy and me, with Mandy Rineer leading the hymns.
- That same afternoon, we welcomed the Munhall Community Band to the sanctuary to
 present their summer concert (rescheduled from May). Mandy Rineer has been a member of
 this group for several years (and is now assistant director!) and reached out to see if FPCE
 could host. As a result of the first meeting with MCB, Jim Segedy joined and now plays
 percussion with them!
- The Edgewood Symphony Orchestra formalized their partnership with FPCE by becoming
 official tenants and moving their offices and music library into our building upstairs at the
 end of July.
- Mandy and Sunny led music while I was on vacation.
- August 21 & 22 brought the Vocal Confluence summer show to our sanctuary.

Fall

- The Choir returned after their summer hiatus on Rally Day.
- Sunny and I had the privilege of leading music at Jason's ordination service at the end of September.
- We realized that Sunny hadn't taken any time off since Covid, so she finally took a Sunday off, and I covered on piano (with a special surprise first hymn on the organ!)
- December was by far our busiest musical month that included performances by the Edgewood Symphony, Munhall Community Band (with our Sanctuary Choir and the choir from Anne Ashley United Methodist Church of Munhall joining on 2 selections), Vocal Confluence (joined by the Renaissance City Choir at 2 shows in one weekend), a recital by Sarah Steranka's flute studio, and my students in the North Hills Singers during and after worship.
- We joined with the members of Waverly Presbyterian Church for their Blue Christmas service that included musical presentations by Sunny Sakai and David Falk.
- Christmas Eve we were joined by Sarah Steranka on the flute.
- For our Christmas Day "from Home" video presentation, I played a tune on the organ, and Sunny played a beautiful solo jazz piano arrangement as well as a duet with daughter Inori Sakai on violin.

We already have several requests to use our space for musical performances in 2023 beyond our regular ESO, VC, and Flute Studio tenants. As word gets out through social media about our beautiful, historic, and acoustically appealing sanctuary, we hope to continue being gracious hosts that allow many "joyful noises" to be made. "Let this house proclaim from floor to rafter: all are welcome in this place!"

STEWARDSHIP REPORT

On November 13, 2022, we held a Stewardship Sunday where pledge cards were discussed and received. Tyler McGuigan gave an inspired heartfelt discussion on what stewardship means to him. It has also helped that Pastor Jason has discussed stewardship and sent correspondence addressing the same. Indeed, in 2022, we received more pledge cards than our 2021 ten card threshold.

During this year, we managed to thrive after the loss of past larger donors and the death of dear members. We decided to use investment income so that we could call a full time Pastor and have had newer members take on positions of responsibility. The advent of our new Pastor led to the implementation of new ideas and programs with increased involvement. We had triple the number of attendees at our last planning meeting. Thanks be to God for your faithful participation!

Thus, we continued to show our love for God by contributing our time, talents, and resources to the Church. We continued to receive our tithes and offerings. Although our annual giving may be slightly less than budgeted, it is strong and steady.

We continued to utilize a weekly liturgist to help the Pastor. The goal is to promote member participation.

In October, we reinstituted our pre-Covid communion procedure. Pastor Jason began serving communion as we come forward. We continued with monthly Emerging Worship services with the Emerging Music Ensemble. On October 4, 2022, we held a pet blessing service on the side lawn.

In December, Shaun's North Hill Singers joined us for a greatly anticipated and appreciated Worship Service. Christmas Eve Service featured flautist Sarah Steranka as well as our musical team. Christmas Day Service was a wonderful, prerecorded collaboration led by Pastor Jason with substantial contributions by creator Lisa Segedy and editor Shaun Cloonan. Christmas Day Service featured contributions of over 50 individuals with formal and informal elements. At the meeting I missed due to a positive covid test, we decided to try something new since Christmas fell on a Sunday this year. Although I was initially uncertain, I believe this was a great success. As the year drew to an end, we submitted 2023 communion dates for sessions approval.

The Services continue to be both recorded and livestreamed and available for later viewing.

In May and June respectively, they hosted *Muffins for Moms* and *Donuts for Dads*. They also hosted their annual Strawberry Festival, selling out! The deacons worked together to provide hot dogs and angel food cakes.

In November, Shady Side Academy filled our food pantry. Rick met with the students and explained how their excellent work would help those in need. There was so much food that Rick took some of the food to Wilkinsburg Community Ministry. Rick and I have worked to stock three "Mini Food Pantries" in the church. There is one at both entrances of the sanctuary as well as one in the fellowship hall. We've seen items taken and items dropped off. We are excited these are getting used by all the groups who use the building during the week.

Deacons continue to call upon our homebound members and provide companionship, taking them Easter baskets, Harvest baskets, and Christmas poinsettias.

Being new to FPCE, I'm sure there is much work I failed to recognize in this brief report, but I am extremely excited to work with the deacons in the new year as we seek to care for this community and our neighbors.

TREASURER'S REPORT

2022 was a financially successful year for FPCE. Income exceeds expenses for a \$8,116.39 surplus, although the revised budget reflecting Pastor Jason joining us in mid-September projected a deficit of \$41,846.26. The difference can be attributed to the Willock and McFadden Trust Funds increasing their distribution, Special Gifts (contributions for use of the church facilities) being over budget by \$9,606.25, and Other Contribution (bequest, memorials, etc.) exceeding budget by \$30,100.00 Other Contributions included unexpected bequests totaling \$9,000.00 and a Cares Act Employee Retention Credit for \$22,000.00. The Trust Fund and Special Gift increase will continue in 2023, but the Other Contribution items will not repeat.

Expenses in 2022 are all generally within budget. Utility costs have risen due to the increased cost of electricity, gas and water/sewage, and the increase in use of the church by outside groups.

The balance sheet shows that we have sufficient cash to start the new year without using investment funds. The PHLF loan has a balance of \$60,761.22 and we continue to make monthly payments of \$1,000.00. FPCE investments are primarily stocks, and they are down to \$740,084.96 (combined value of unrestricted and restricted) at the end of the year. 2022 was not a good year for stock market investment, but FPCE has benefited from the previous year's large increases.

The budget for 2023 shows a deficit of \$117,079.77 primarily due to the addition of a full time Pastor, the non-occurrence of the one-time income items in 2022 and the reduction of Account 4010-Donations. Congregation donations have been shrinking for years and is a problem that needs to be addressed.

It is recommended that an outside person or entity be engaged to audit all records of the Church. This person or entity should not be affiliated with the Church.

BY-LAW REVISIONS

- Article II, Section 7 of Congregation: shifting a quorum from "25 people or 10%, whichever is greater" to 25% of the congregation's members.
- The first paragraph of Article V is adopted from the Pittsburgh Presbytery's manual for committees:
 - After absence without excuse from two (2) consecutive regular meetings of the Session or Board of Deacons, a member thereof shall be notified by the body of membership that, after the third consecutive unexcused absence, the member will automatically forfeit the right of membership and that the vacancy will be filled by the Congregation upon nomination by the Nominating Committee.
